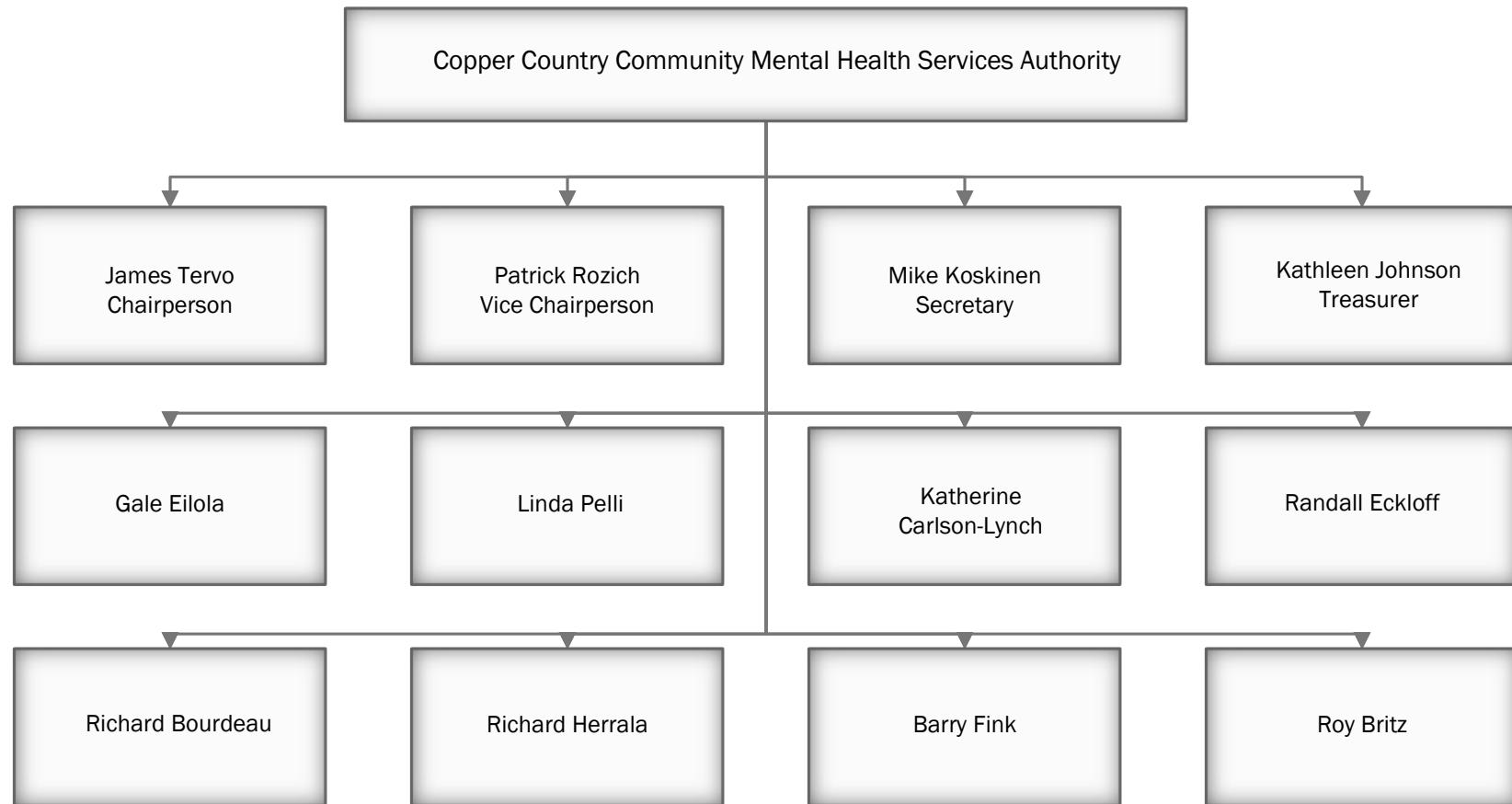

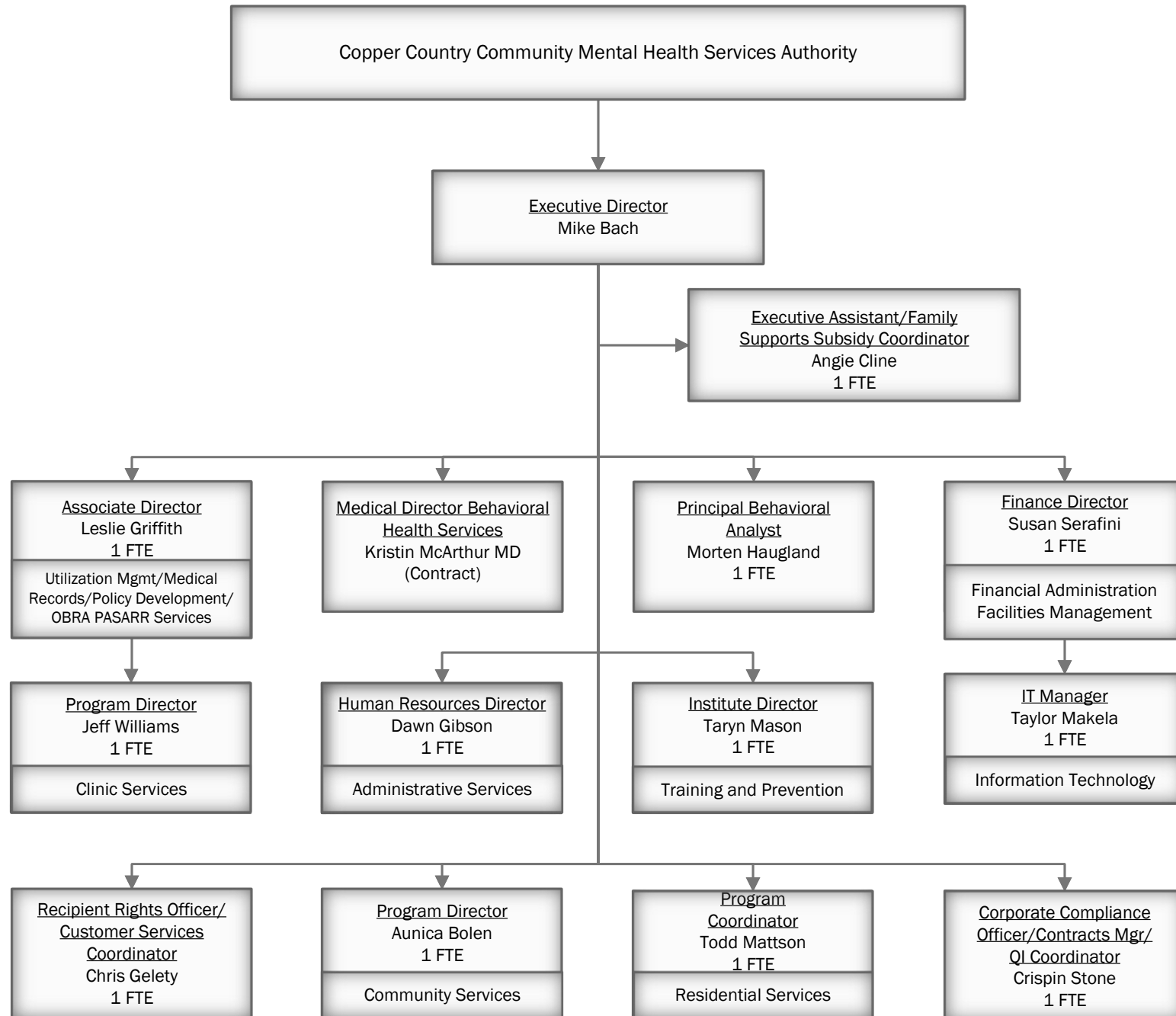

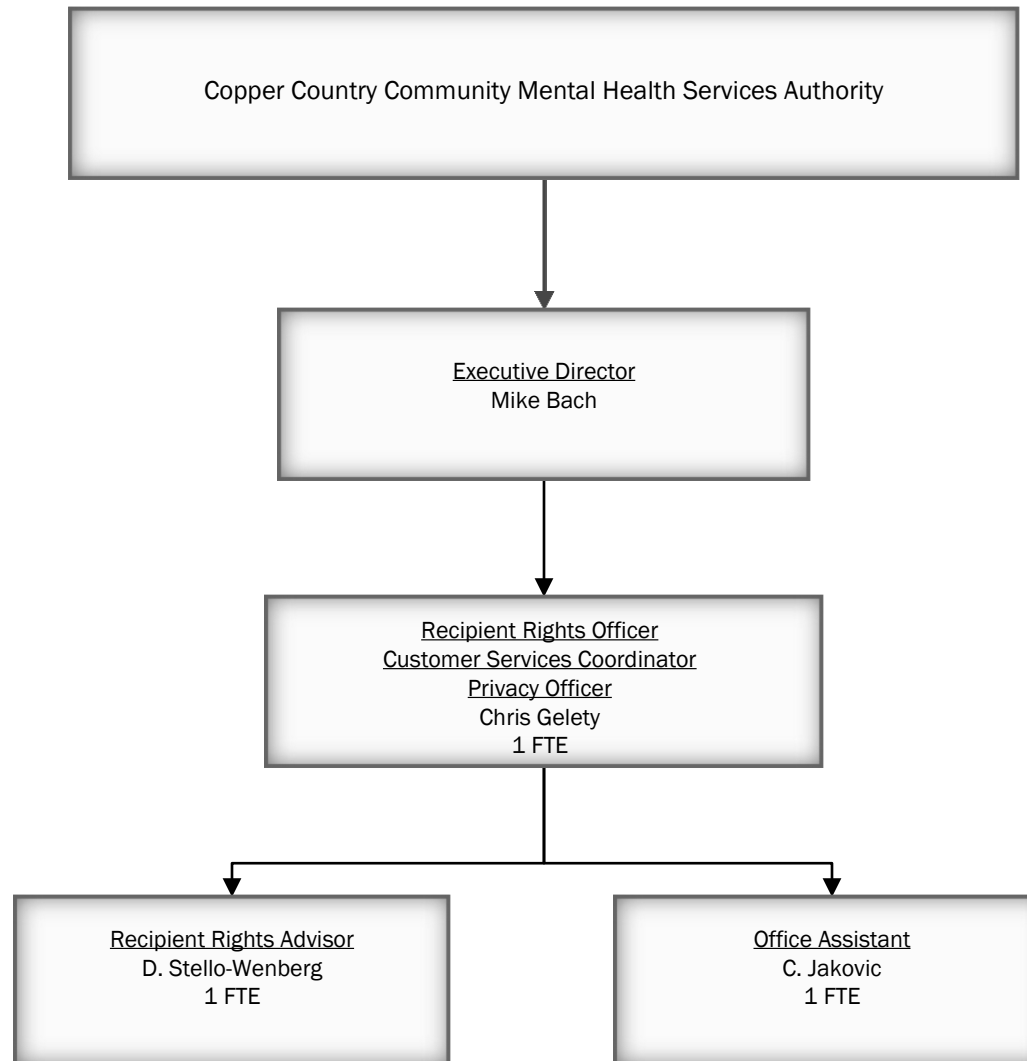
Board Structure



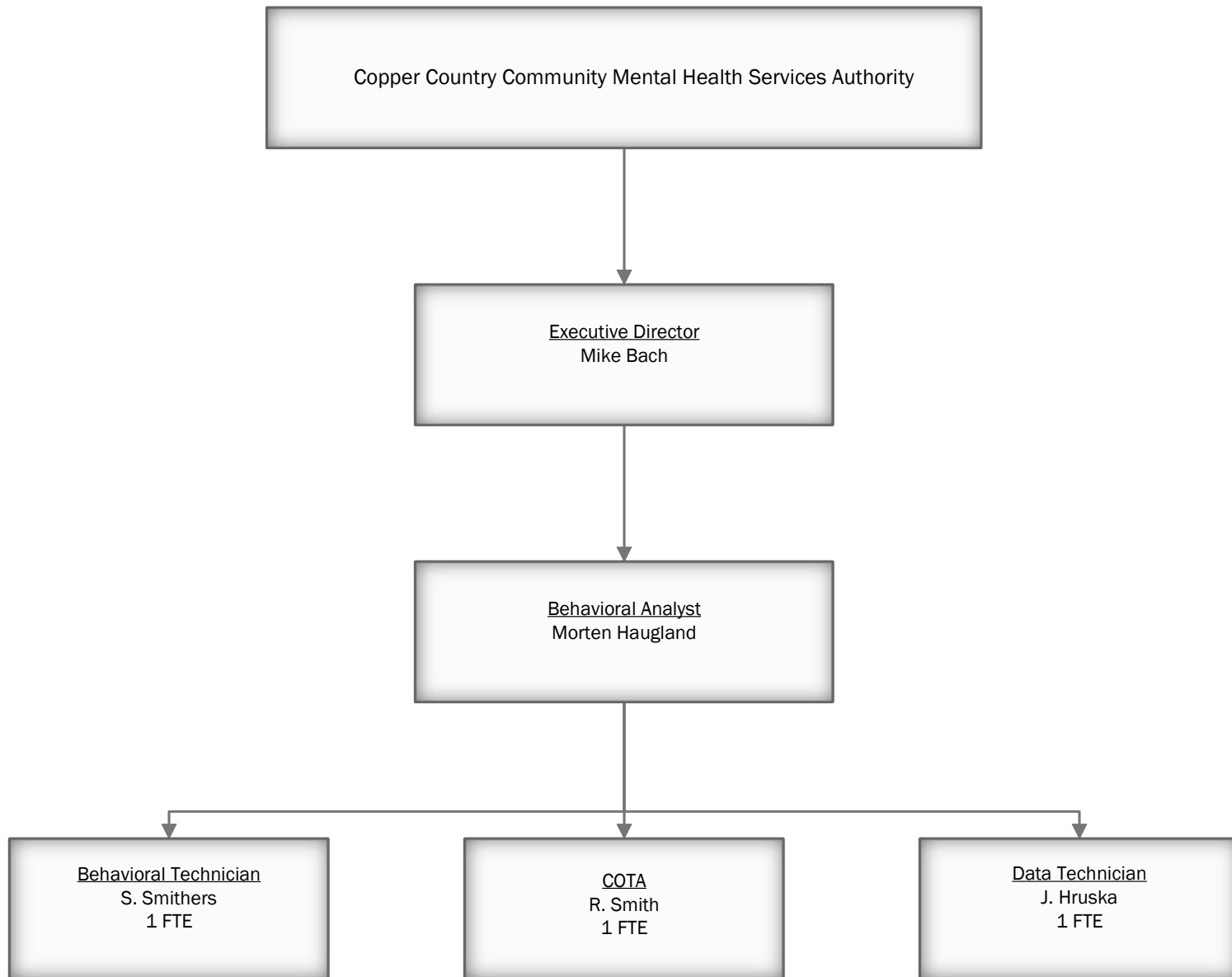
Management Structure



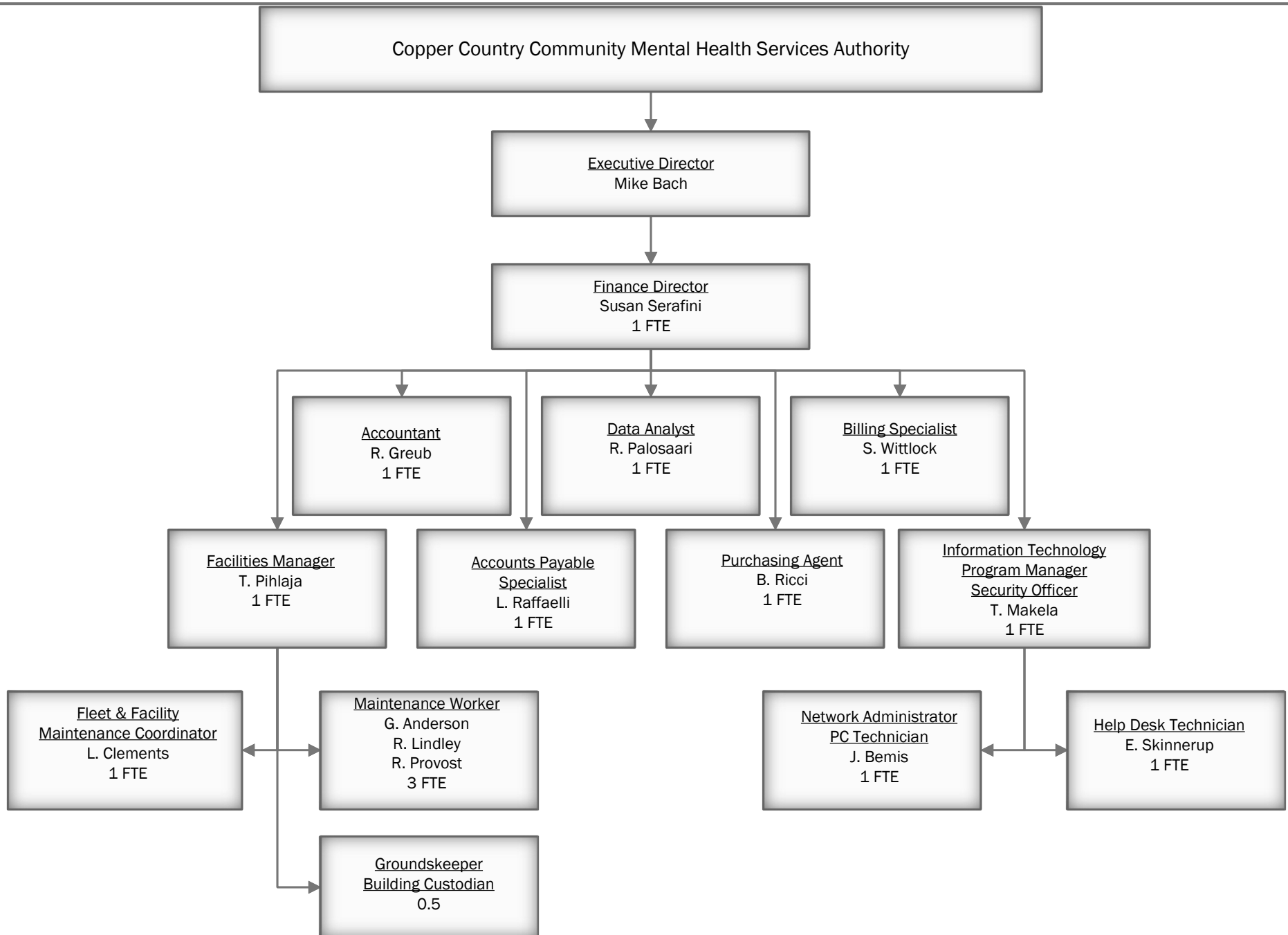

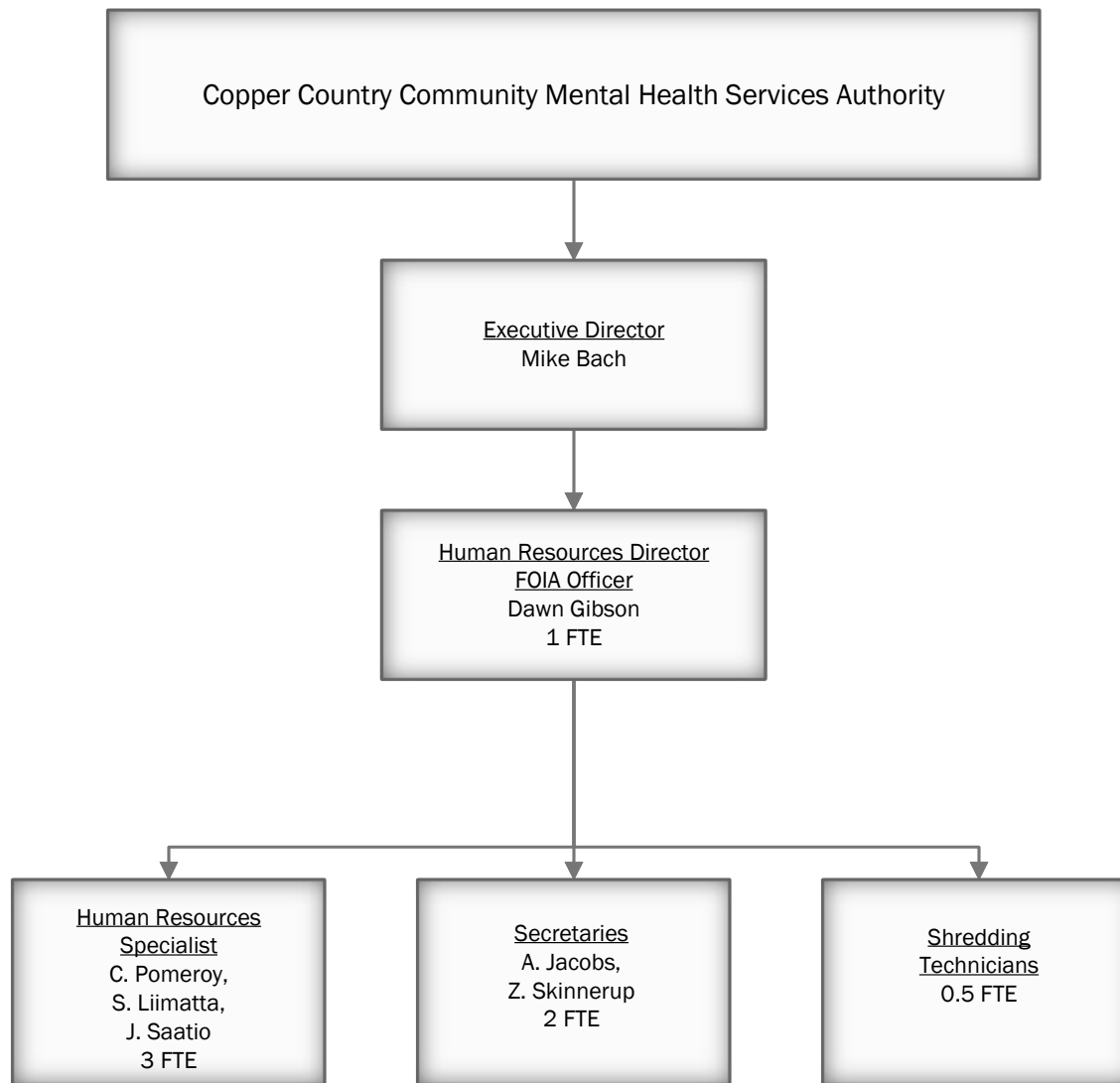
